**From San Francisco:** Take US-101 S toward Oakland (I-80 E). Take the Bay Bridge/Oakland. Take the Hayward-Stockton (CA-24) exit onto I-580 E. Take left fork onto I-205 E toward Tracy/Stockton. Exit onto I-5 N. Take exit #461/Manteca/Sonora onto CA-120 E. Take the Modesto/Fresno exit onto CA-99. Take the Bradbury Rd exit, turn left on W Bradbury Rd. Turn left at Vincent Rd. Turn right at Lombardy St, follow down to 14886.

**From Sacramento:** Take I-5 S toward CA-99 S/I-80-BR. Take the Downtown Stockton/Fresno Avenue exit onto CA-4 E toward CA-99. Take the Fresno exit onto CA-99 S. Take the Bradbury Rd exit. Turn left on W Bradbury Rd. Turn left on Vincent Rd. Turn right at Lombardy St, follow down to 14886.
